

ADMISSION

York University's Office of Admissions is mandated to ensure that all qualified applicants are considered for admission in a fair and equitable manner. The University makes offers of admission to the most qualified candidates. However, if you feel that your academic record does not reflect your abilities, you are invited to present documentation outlining circumstances that may have affected your academic performance.

Categories of Admission

There are several possible paths for achieving your undergraduate academic goals at York University. Here are brief descriptions of each category of admission:

Undergraduate Degree

Individuals with appropriate preparation may apply for admission to complete an undergraduate degree at York. Degrees requiring postsecondary experience are the Bachelor of Science in Nursing and the Bachelor of Social Work.

Undergraduate Certificate

Certificate programs offer students the opportunity to take a coherent grouping of degree courses in a specialized area of study. Individuals may apply for admission to complete an undergraduate certificate.

Visiting Student

The University will consider individuals who wish to take credit courses at York, but who do not intend to complete a degree or a certificate. This category is open to individuals who already hold an undergraduate degree, or who are currently attending another recognized university and wish to take courses on a Letter of Permission granted by that university.

Provisional Student

In very exceptional circumstances, the University will admit, for a period not to exceed one academic year, (normally in anticipation of admission as a degree candidate) individuals on a provisional basis. Such provisional status is granted at the discretion of the University and on the basis of the bona fide presentation of sufficient grounds to sustain a reasonable presumption of an applicant's ability to complete the requirements for a degree or certificate.

Admission Requirements

Consideration for admission is given to applicants presenting outstanding academic credentials provided that they are earned at recognized/ accredited institutions. The following chart identifies some of the academic preparation York University recognizes:

| University Transfer | <p>Degree-credit studies at an accredited university with a minimum average of C for admission (C+ for admission to an honours program). Documents submitted in French do not require translation.</p> <p>International transcripts are reviewed in reference to the grading scale reported by the institution.</p> <p>Failed courses are included in the calculation of the admission average.</p> |
| Ontario College of Applied Arts and Technology | <p>2 year (4 semester) CAAT Diploma with a grade point average of 3.0 on a 4 point scale (B); or the completion of eight semestered academic courses with a minimum grade point average of 3.0 on a 4 point scale (B).</p> <p>Failed courses are included in the calculation of the admission average.</p> |

| Mature Student | Applicants may apply as Mature students if they meet all the following criteria: out of full-time secondary school for at least two years, attempted less than four full courses at a university, no recent unfavourable academic performance, demonstrated potential for success in university level studies through academic, professional and other accomplishments and is 21 years of age or older as of the first day of classes. |
| Senior Citizens | Senior Citizens who wish to be admitted to the University are evaluated as mature students unless the individual has completed previous postsecondary studies (see appropriate sections in chart above). Applicants must be 60 years of age or older on the first day of classes for which they have applied. In order to be exempted from the Domestic Fee Rate, Senior Citizens must meet the rules and regulations outlined by the Office of the Registrar, telephone (416) 736-5440. |

Note: All applicants must meet the prerequisite and minimum average requirements for the programs to which they have applied. Requirements vary by program. Applicants are encouraged to visit our Web site at <http://www.yorku.ca> (click on Admissions) for more detailed information.

Language Proficiency Requirements

York University seeks to ensure that students are able to satisfy the demands of university-level work in English.

Applicants must successfully complete an English* language proficiency test or meet one of the following language proficiency criteria:

- completed four years of full-time secondary school studies where English* is the official language of instruction;
- completed the equivalent of one full year of postsecondary study in an accredited institution, and in a country where English* is an official language;
- completed four years of full-time secondary school studies or the equivalent of one full year of postsecondary study in an accredited institution in Canada.

**Applicants to our Glendon campus may establish their proficiency in English or French.*

All other applicants must provide proof of their English proficiency by submitting acceptable results on one of the following English language tests:

Language test scores are reviewed in combination with academic credentials to determine admissibility to the University.

- English as a Second Language (ESL) support for admitted students is offered through degree credit programs.

- Non-credit ESL instruction is available prior to university study through the York University English Language Institute. Contact (416) 736-5353 for more information.
- Candidates with strong academic averages but whose language test scores fall slightly below these posted ranges may still be reviewed for possible conditional admission.

Application Procedures

Application Forms:

Current Ontario high school students must contact their guidance office to apply to the University. Please use the 101 application form provided by the Ontario Universities' Application Centre. High school students who are 21 years of age or older are urged to apply using the 105D application form.

University students transferring from an Ontario university are encouraged to use the 105D application form available at all Ontario university admission offices. This form allows you the opportunity to have your transcript sent to us electronically.

All other applicants may apply in one of the following manners:

1. The 105D application form provided by the Ontario Universities' Application Centre. This form enables you to apply to several Ontario universities on one form.
2. The York University Undergraduate Application form provided by the Office of Admissions.
3. The York University on-line application form available at our Web site at <http://www.yorku.ca> (click on Admissions).
4. The 105F application form may be used by international students who are applying from outside of Canada and choosing more than one Ontario university.

Admission to Bachelor of Social Work Degree

The Bachelor of Social Work (BSW) is an Honours degree. The number of applicants to the Social Work program generally exceeds the number who can be accepted. Selection into the program is based not only on academic ability, but also on professional potential.

Applicants must hold an undergraduate degree in order to be eligible for admission. The entry procedures include the following criteria: academic achievement, work, volunteer and community experience, personal statement, problem statement, academic record and references. An interview may be required.

Social Work Supplementary Admissions Information Form

This form is provided with the Bachelor of Social Work application package and is a required part of the application process. The application package is available from the Office of Admissions. The application deadline is January 31.

Admission to Bachelor of Science in Nursing Degree

The Bachelor of Science in Nursing (BScN) is an Honours degree that is offered as two distinct programs. The Department of Nursing also offers two certificates.

- 1. Post-RN Program.** This program is for Registered Nurses. Information about the BScN program may be obtained from the Department of Nursing (416) 736-5271 or from the Office of Admissions at (416) 736-5000.
- 2. Collaborative Program.** This program is for students who have successfully completed two years of a Collaborative Program in Nursing at Georgian or Seneca Colleges of Applied Arts and Technology, or other approved Collaborative Program Partner College of Applied Arts and Technology. For further information, applicants should first contact the Departments of Nursing at Georgian or Seneca College, or other approved Collaborative Program Partner College.
- 3. Primary Care Nurse Practitioner Certificate.** A Primary Care Nurse Practitioner Certificate is also available for Registered Nurses holding a completed Baccalaureate Degree in Nursing or concurrently enrolled in the York BScN program. This certificate may be taken on a full-time or part-time basis. Information can be obtained from the Department of Nursing at (416) 736-5271.
- 4. Health Informatics Certificate.** Students enrolled in the BScN degree may take the Health Informatics Certificate concurrently. Information can be obtained from the Department of Nursing at (416) 736-5271.

Supplementary Application Form

This form is provided with the Bachelor of Science in Nursing degree application package and is a required part of the application process. The application package is available from the Office of Admissions.

Special Needs Services

The Office for Persons with Disabilities offers assistance to students with physical disabilities and our Learning Disabilities Program offers services to those with learning disabilities.

Applicants with special needs are encouraged to contact the Office of Admissions for further information. All pertinent documentation for admission consideration should be submitted by February 1.

Application Deadlines

The dates provided are final deadlines. It is the responsibility of applicants to ensure they meet application deadlines and requirements. Applicants are strongly encouraged to apply and provide official documentation very early in the application process.

*International applicants and domestic applicants to limited enrolment programs (e.g. Nursing and Social Work) are encouraged to apply by the early deadline date. *Some programs fill much earlier than the deadlines indicated.*

Eligibility for Advanced Standing (Transfer Credit)

Applicants who present accredited postsecondary studies and have satisfied admission criteria may be eligible for advanced standing or transfer credit consideration. The amount of credit granted depends on the academic content of the program completed, the grades received, and the program to which the student has applied to at York. Eligibility for transfer credit is automatically assessed when applications are processed. Course descriptions are required for all academic work completed outside of Canada or the US at the postsecondary level if applying to a degree program.

Applicants Holding a First Degree:

Students will not be admitted to a second degree in the same major or where their existing studies overlaps significantly with an Atkinson degree program. Students with acceptable standing may reclassify a three-year degree to a four-year degree in the same major.

Students holding a degree and seeking admission to an honours program will be required to have honours level standing in their first degree.

The Senate of York University endorses the following principles:

1. Acceptance of transfer credits among Ontario universities shall be based on the recognition that, while learning experiences may differ in a variety of ways, their substance may be virtually equivalent in terms of their content and rigour. Insofar as possible, acceptance of transfer should allow for the maximum recognition of previous learning experience in university-level courses;
2. Any course offered for credit by one Ontario university shall be accepted for credit by another Ontario university when there is virtual equivalency in course content.

Failure and Debarment

Students who have been debarred may be readmitted in some subsequent session only if they give convincing evidence to the Committee on Admissions that they can benefit from further university work. Applications for readmission will not be considered until two years from the date of debarment. In cases of failure at another university, or where another university's regulations on failure and debarment differ from York's, or where that institution calculates years or semesters differently from the York method, the York regulations will normally apply.
